#### **Background:**

This Special CRA Board meeting is the second meeting in the two-part interview process for the selection of the CRA Executive Director. On June 29, 2020, the CRA Board held the first meeting wherein the two candidates were interviewed on a list of predetermined questions prepared the City's Human Resources Department. The second meeting is designed to provide public participation in the selection process. Communications posted the public announcement on June 24th and it closed at end of business on June 30th. Questions from the public were submitted via email or in a drop box located at the entrance to City Hall.

At the beginning of the Board meeting, the pre-screened questions submitted from the public will be asked by the Board members on a rotational basis. Afterwards, public comments related to the selection of the CRA Executive Director will be allowed. At the conclusion of the question and answer portion of the meeting, the Board will discuss and deliberate on the two candidates. The Board will then make its selection of the CRA Executive Director. The two candidates are:

- Allison Justice: City of WPB Interim CRA Executive Director RMA Employee
- Christopher Roog: City of WPB Economic Development Director City Employee

At the direction of the Board, the City Administrator will negotiate the terms of employment, determine a tentative start date and extend a formal offer to the selected candidate. The CRA Executive Director proposed pay grade is GM17: \$121,330 - \$181,995.
