Background:

The Florida Department of State through the Division of Cultural Affairs provides financial support for the renovation, construction and acquisition of cultural and community facilities. Eligible projects for this funding opportunity include:

- Outdoor Amphitheater/Bandhills
- Performing Arts Centers
- Theaters
- Cultural Centers
- Education Facilities
- Community Centers

Application Deadline: June 1, 2021.

Maximum Grant Amount: \$500,000.

Match Requirements:

1 to 2 match of funds is required, meaning that the matching funds amount must be twice the amount of the grant award. The \$1,000,000 match will come out of the City's Series 2020 General Obligation Parks Bond, as part of the \$8,000,000 budgeted for the construction of Currie Park. The CRA is seeking a grant submittal in the amount of \$500,000 for the improvements to Currie Park.

Resolution No. 21-27 approves the submittal of this grant application, and upon grant award, approves the allocation of funds toward this project.

Background:

The CRA's Strategic Finance Plan for the Downtown/City Center CRA District ("District") identifies target project areas and specific redevelopment activities and funding mechanisms for such projects. For instance, the CRA's Strategic Finance Plan identifies the downtown core as a target area as one of the focus areas with beautification needs. In accordance with the Plan's goals for the District, funding has been allocated to design and beautify Clematis Street and the alleyways.

The City of West Palm Beach ("City") owns and operates three (3) trash compactors within the alleyway behind the CRA-owned building located at 314 Clematis Street and as an art accessory to beautify the referenced alleyway, the CRA has partnered with the City to fund the printing of a digital image entitled "Skateboard Girls Rule" on the City's compactors. This digital image was previously granted Face of the City approval through Resolution 74-21, adopted on May 3, 2021 by the City Commission as part of the temporary public artwork entitled "Energy" by local artist Brian Wood for installation on the back wall of the CRA-owned building located at 314 Clematis Street.

As part of this partnership with the City, the CRA wishes to fund the printing of the digital image to be printed on the City's compactors in an amount not to exceed \$6,600.

Resolution No. 21-28 approves the interlocal agreement to between the City and CRA for an amount not to exceed \$6,600.

Background:

The CRA issued Request for Proposals (RFP) No. 18-19-201 for Professional Architectural & Engineering Design Services for Currie Park. The CRA Board heard presentations from interested firms and selected Chen Moore and Associates (CMA) with which to negotiate a master Professional Services Agreement.

Resolution No. 20-57 approved the master Professional Services Agreement for Architectural & Engineering Design Services which established the overall scope of services for the design of Currie Park, general hourly rates, insurance requirements and other general terms and conditions.

Chen Moore's professional services were organized into two phases:

- 1) Phase I – Information Gathering, Public Engagement, Visioning and Planning
- 2) Phase II – Design, Permitting, and Construction Administration

Phase I commenced on November 2nd, 2020 and included the following tasks:

- Project coordination meetings
- Thorough site investigation
- Coordination with local permitting agencies to develop a permitting path
- A robust public engagement program
- Visioning
- The development of a master plan
- Cost estimating
- A development phasing plan
- Activation, operations, and governance plan
- Revenue strategy and strategic funding plan within existing budget limitations

CMA presented the preliminary master plan to the Parks and Recreation Advisory Committee (PRAC) on April 13th, 2021 and the CRA Advisory Board (CRAAB) on April 30th, 2021 for discussion and feedback. The final master plan including 100% schematic design construction documents with associated cost estimates, was brought in front of PRAC on May 11th, 2021 and CRAAB on May 28th, 2021 for recommendation of approval.

The Master Plan (Phase I) enhancements include: an Entry Plaza, child Play Area, Waterfront activity area, Downtown Overlook, Picnic/Cafe area and a Tidal Amphitheater. The Master Plan also proposes a Phase II which includes a marina.

Resolution No. 21-24 approves the Master Plan for Currie Park as presented by CMA.

Upon approval of the Master Plan, the detailed scope of phase II services for CMA, and associated costs, will be brought forward in July 2021 for approval as an amendment to CMA's master contract. This includes design, permitting, and construction administration.

There will be a companion item on the City Commission Agenda as Resolution No. 121-21.

Background:

On November 7, 2005, the Community Redevelopment Agency (CRA) adopted the Strategic Finance Plan for the Northwood/Pleasant City CRA District. This consolidated plan includes redevelopment initiatives designed to attract private investment and redevelopment activities within the Northwood/Pleasant City Community Redevelopment Area.

The CRA Facade and Exterior Improvement Grant Program is an incentive available to businesses located within the Northwood/Pleasant City CRA District for improvements to the exterior of commercial properties and buildings. Eligible activities include painting, repair and other architectural elements attached to the building exterior, awnings, exterior door and window replacements, landscaping, parking lot improvements, lighting and decorative pavement. The CRA will provide a grant for 80% of the project cost up to a maximum CRA grant of \$10,000 for projects within Northwood Village, Pleasant City, Currie Park and the Industrial District. Reimbursement percentage for exterior door and window replacement is 50% of their cost. In order to be eligible, properties cannot be listed for sale and must be free and remain free of all municipal and county liens, judgements, or encumbrances.

The subject grant is being sought by Shoreline Holdings and Investment Properties, LLC., property owner of 2500 Broadway Avenue, to assist in the exterior improvements of the building and property. The scope will include landscaping, irrigation, decorative gates, paint and fencing. The subject property was formerly the Sunset Grill and was purchased in May 2020 by Shoreline Holdings and Investment Properties, LLC, for their general contractor business, Shoreline Building Group. The total construction cost per this application is estimated at \$25,860. The petitioner received two (2) licensed contractor bids, as required for each scope of the project and is requesting a grant contribution of \$10,000 per the CRA's Facade and Exterior Improvement Grant Program.
