**Background:**

The previous owner of 624 32nd Street was cited numerous times for code violations on the property, including violations involving roof replacement, boarding permit, unpermitted fence, driveway repairs, and the painting of the structure. As a result of the previous owner's failure to repair the property, a fine has accrued to approximately \$165,200. A new owner has recently purchased the property and has begun obtaining permits to rehabilitate the property. The rehabilitation of the property will eliminate unpleasant conditions and improve the area. This resolution would allow the release of the \$165,200 fine/lien, if certain conditions are met, including payment of an \$8,000 administrative fine, payment of any outstanding utility liens or taxes, and completion of the property rehabilitation by February 7, 2022.

**Fiscal Note:**

Approval will conditionally release the \$165,200 fine/lien in exchange for, among other conditions, an \$8,000 administrative fee, payment of any outstanding debt owed to the City, and payment of any outstanding taxes.

**Background:**

The University of North Florida Training and Services Institute, Inc., d/b/a Institute of Police Technology and Management ("IPTM") is the recipient of a grant from the Florida Department of Transportation (FDOT) for the education and enforcement of Pedestrian and Bicycle safety laws. The funding is intended to support activities that should reduce pedestrian and bicycle crashes as they are more likely than any other types of crashes to produce serious injuries or fatalities. West Palm Beach was awarded a portion of the funding allocated to the University of North Florida for the administration of the FDOT grant.

The award notification was received July 2021 providing \$28,982.17 to the City through a vendor agreement with the University of North Florida Training and Services Institute, Inc., d/b/a Institute of Police Technology and Management ("IPTM") for the purpose of providing reimbursement for overtime costs incurred for the public education and enforcement of bicycle and pedestrian safety.

This Pedestrian and Bicycle Safety Enforcement Campaign is approved for overtime hourly costs plus benefits for operations to be completed with sworn Police Officers at locations identified by the grantor and are to be carried out between the date of document execution and May 13, 2022. The approved intersections/corridors to conduct operations are identified within the scope of this grant as:

1. US-1, 42nd Street – 51st Street
2. 45th Street, Military Trail to I-95
3. 45th Street, 300 feet east and west of Congress Avenue
4. 45th Street, Australian Avenue to Greenwood Avenue
5. Palm Beach Lakes Boulevard, Congress Avenue to Flagler Drive
6. Okeechobee Boulevard, I-95 to US-1

Each year, if the City meets the terms set forth in the agreement, additional grant funds may be awarded. Those funds are accepted through an amendment to the grant documents and must be executed by all parties before the additional overtime is performed.

**Fiscal Note:**

Approval will provide funding for reimbursement of police overtime for traffic education and enforcement.

**Background:**

The City entered into a Trolley Operating Agreement with Hoffmann PB Trolley's, LLC (the "Operator") for operation of the City's trolley system. The Agreement expires on September 30, 2021 and has no renewal options. Prior to COVID-19, the City had completed the mobility study and was in the process of developing a request for proposals to solicit a new contract, which would have included expansion of the trolley system and modified routes. The solicitation was scheduled to be released during the pandemic after trolley operations had stopped within the city.

Due to uncertainties of COVID-19 and uncertainties related to the future operation of the trolley system, the parties desire to extend the current trolley operations agreement for an additional year, to September 30, 2022 to allow the City further time to re-establish the trolley operating system and to prepare a solicitation.

This amendment modifies the contract as follows:

1. For the renewal term commencing October 1, 2021, the Hourly Rates for operation of the Yellow Line, Green Line and Blue Line shall be increased by 2%. The City shall pay Operator an hourly rate of \$68.85 per hour. There shall be an hourly surcharge of \$15.00 per hour for services provided on the holidays set forth in the Agreement.

**Background:**

The State of Florida Department of Transportation ("FDOT") acquires properties for transportation facilities for the citizens of the State of Florida. FDOT is permitted by law to release and convey real property that FDOT no longer needs for roadway purposes, and determines to be surplus, to other public entities to further the public needs of the State of Florida.

The City of West Palm Beach owns an approximately 172-acre area within the City, which has been used since 1947 as the City's public golf course.

The State of Florida was granted approximately 2.1-acres for roadway/right-of-way purposes by the City of West Palm Beach, adjacent to the City's public golf course and the Interstate-95 right-of-way. FDOT has now declared this 2.1-acre parcel as surplus.

Pursuant to Sec. 337.25(4)(b), Florida Statutes, FDOT may convey surplus property to another government agency, at no cost, provided that the property will be used for public purpose.

The City, and its lessee, West Palm Golf Community Trust, desire to incorporate these 2.1-acres into the redeveloped public Golf Course, and request that the surplus property be conveyed back to the City by FDOT. Conveyance to the City will serve a public purpose by providing outdoor recreational use, as such property will be incorporated into the City's public golf course for the use and enjoyment of the general public.

The deed from FDOT will contain a reverter clause that provides that the property will revert back to FDOT if it is no longer used for a public purpose.

Resolution No. 239-21 is the City's formal request to FDOT to convey the 2.1-acre surplus property to the City for use as part of the public Golf Course.

**Background:**

The Mandel Public Library of West Palm Beach is dedicated to making local history available and accessible to the local community, library patrons, and visitors. A series of traveling history exhibits will be a way for the Library, through a partnership with the Historical Society of Palm Beach County, to bring local history to the forefront for our patrons. The Library will host the exhibits in the Urban Living Room of the Mandel Public Library of West Palm Beach for all of our patrons and visitors to enjoy. The Library will host an exhibit titled "Greetings from the Palm Beaches" from September 1-30, 2021. The Library will host an exhibit titled "City of Hope" in celebration of Black History Month from February 1-28, 2022. The Library will host an exhibit titled "Women's Suffrage" in celebration of Women's History Month from March 1-31, 2022. These exhibits will be provided to the Mandel Public Library of West Palm Beach free of charge.

Resolution No. 188-21 approves the Exhibit Agreement with the Historical Society of Palm Beach County.

**Background:**

Florida's State Aid to Libraries Program is administered by the Florida Department of State, Division of Library and Information Services. In 2003, the Legislature revised the law to allow independent municipal libraries to participate in the State Aid to Libraries Program. This was done in recognition that the provision of state aid to independent municipal libraries is a valuable contribution to the extension of the state's public library development plan. The State provides a match of up to 25 cents on each dollar of local funds expended centrally for the operation and maintenance of the library. The Mandel Public Library of West Palm Beach has received State Aid funding since 2003.

The Mandel Public Library meets the following requirements to receive the State Aid to Libraries Grant: 1) provides free library services; 2) maintains an established interlocal agreement to jointly support each participating library; 3) retains a single administrative head employed full-time to manage or coordinate the operations of the library; 4) expends funds centrally; 5) maintains a reciprocal borrowing agreement; 6) provides access to materials, information, and services for all residents of the area served; 7) library is open 40 hours or more each week; and 8) has established a long-range plan, annual plan of service, and annual budget.

Funding from the state may only be used for operating costs and will supplement the Mandel Public Library's operating costs for goods and services as defined by the Uniform Accounting System Manual for Local Governments, 2008 Edition, prepared by the Florida Department of Financial Services, Bureau of Local Government.

The State will determine the amount of grant to be awarded to the City; however, it is estimated to be up to \$91,179.

Resolution No. 206-21 approves submittal of the grant application.

**Background:**

The workload at the Water Treatment Plant (WTP) lab has increased substantially over the last six (6) months due to the increased demand for water quality data related to algae and algal toxins. This increased demand is expected to remain high for the foreseeable future. The work on algae is high profile for the City and has required that the lab provide a greater level of sampling, analysis, documentation, and reporting than in the past.

**Fiscal Note:**

Post approval, Water and Sewer Operating Contingency balance will be approximately \$2.7M.

**Background:**

A claim has been brought by Maria Di Bartolo, as Personal Representative of the Estate of Michael Di Bartolo and Maria Di Bartolo, individually, against the City of West Palm Beach for damages stemming from an accident on September 20, 2019. A Conditional Settlement Agreement has been reached with Ms. Di Bartolo on behalf of herself, the Estate, and all beneficiaries to resolve the matter for \$200,000. Ms. Di Bartolo has signed a general release that releases the City from all claims arising from this accident, which ends all of the claims for damages, including all attorneys' fees and costs, against the City of West Palm Beach.

Section 2-268(g)(4) of the Code of Ordinances of the City of West Palm Beach, Florida, provides that the authority for settlement of all claims over \$30,000 shall require the approval of the City Commission by formal resolution. Resolution No. 222-21 approves the Conditional Settlement Agreement.

9. **Resolution No. 219-21 **APPROVED** deferring the three percent rate increase for stormwater service fees scheduled for October 1, 2021, so that there is no stormwater rate increase this fiscal year.**

**Background:**

Pursuant to Resolution No. 277-16, which was adopted on August 29, 2016, the City automatically increases the fees and charges of the Stormwater Management Utility by three percent (3%) on October 1st of each respective fiscal year. The purpose of the adjustment is to provide a cost recovery mechanism associated with the estimated effects of inflation and to maintain operating margins (revenues after the payment of operating expenses) for capital reinvestment and payment of debt service on outstanding bonds.

Public Utilities staff and its rate consultant, Raftelis Financial Consultants, Inc., are currently conducting a stormwater rate study, which is anticipated to be complete in the next several months. It has been determined that the stormwater rate increase of three percent (3%) scheduled to be effective October 1, 2021, can be deferred until October 1, 2022. Raftelis has provided a letter confirming the revenue sufficiency of the Stormwater Utility for fiscal year 2022. Upon completion of the stormwater rate study, the recommendations and findings will be brought before the City Commission for review and approval.

It is recommended the City Commission approve Resolution No. 219-21 deferring the three percent (3%) scheduled stormwater rate increase scheduled for October 1, 2021.

Fiscal year to date through July 30, the stormwater utility has collected \$12.7M in stormwater fees. The total projected fiscal year 2021 stormwater fee revenue is approximately \$15.3M.

**Fiscal Note:**

Three percent (3%) of the projected fiscal year 2021 stormwater fee revenue represents approximately \$459,000.

**Background:**

The City and the Professional Managers and Supervisors Association Certified Unit #1073 (PMSA) have reached a tentative Memorandum of Agreement (MOA) modifying Article 27, Compensation, Section 1. **Background:**

A. and 3. C. 4. of the parties' October 1, 2020 to September 30, 2023 Collective Bargaining Agreement (CBA), which was ratified by the City on September 21, 2020. The proposed MOA would be a two (2) fiscal year (FY22 & FY23) MOA. If ratified, the MOA would provide a 5% across the board Cost of Living Adjustment (COLA) in FY22 and a 5% across the board COLA increase in FY23 for all employees holding SEIU represented job classifications as set forth in the MOA. **Background:**

Due to the challenges faced by the City in developing a balanced FY21 budget, non-represented employees did not receive a 3% cost of living (COLA) increase during FY21. This resolution, if approved, would provide non-represented confidential employees and employees in the job classification of Executive Administrative Assistant, a 3% COLA during this fiscal year 2021, retroactively effective to the pay period beginning on April 4, 2021.

The FY21 estimated cost is \$46,000 in General Fund; \$4,400 in Utilities Fund; and \$1,800 to Internal Service Funds.

**Fiscal Note:**

Estimated costs related to this pay increase can be funded from vacant position cost savings realized in FY21.

**Background:**

Due to the initial severe economic impact of the COVID-19 pandemic, the City established the COVID-19 Recovery Assistance Program through Resolution No. 100-20 that was approved by the City Commission on March 23, 2020. The program created micro-loans of up to \$10,000 for local businesses impacted by the COVID-19 economic downturn. The loans were funded through a general fund allocation of \$259,000 along with companion funding from the City Community Redevelopment Agency (CRA) and the Downtown Development Authority (DDA). The loans were underwritten and serviced through a partnership with the Urban League of Palm Beach County and Valley National Bank. A total of 47 loans received funding from the three (3) funding sources.

The terms of the loans allowed for the first 12 months to be interest only payments with principal and interest payments beginning on the 13th month with a total repayment term of five (5) years. Several of the borrowers have reached out to the City requesting that the principal balances be forgiven or reduced given the substantial impacts of the initial economic downturn and the uncertainty surrounding new COVID-19 variants that could again limit economic activity. City staff met with Valley National Bank, CRA, and the DDA to discuss principal forgiveness options and are recommending that borrowers who are able to pay 50% of the initial principal loan balances in full on or before December 31, 2021 be granted forgiveness of their remaining principal balance equaling an amount not-to-exceed 50% of the initial principal. It should be noted that none of the loans are delinquent.

Due to the financial hardships incurred by the businesses that were assisted, the uncertainty of the economic impacts that COVID-19 variants may have and that the City will partially recoup nearly half of its investment immediately, staff recommends that the COVID-19 Recovery Assistance Program be modified to allow for a partial forgiveness of principal equaling 50%. Additionally, due to COVID-19 and its variants, some businesses are experiencing financial hardships that are making it difficult for the business to repay the loan at the present time. The City desires to further amend the loan program to allow a business experiencing a financial hardship to request a principal payment deferment for a period not to exceed six (6) months. If the deferment is granted, the business will still be required to make interest payments during the deferment. Additionally, due to the structure of the City's loan program, the loan maturity date for any loan granted a deferment shall remain unchanged. When the deferment period expires and the loan is placed back into repayment status, Valley National Bank will advise the business of the updated monthly payment amount. Providing for an optional six (6) month deferment will allow businesses that are struggling to continue to recover and re-enter repayment in hopefully a stronger financial position.

**Background:**

The City of West Palm Beach owns property located at 1100 Okeechobee Road (PCN: 74-43-43-28-09-008-0010). Pursuant to the Florida Contraband Forfeiture Act under Sections 932.701-704 of the Florida Statutes (1989), the City was awarded ownership of the property on the December 20, 1990. Final judgement and order of forfeiture is included in this agenda item. The property has been vacant for over three (3) decades and is not being utilized for any special purposes in accordance with the requirements set forth in the Florida Statutes.

On April 5, 2021, the City received a letter of intent to purchase the property from Marto Rentals 2, LLC. The interested party intends to utilize the site for expansion of Property Works, a minority owned small business located at a neighboring site and intends to create 10 - 15 local jobs to be offered to West Palm Beach residents.

The registered agents for Marto Rentals 2, LLC are also the owners of Property Works, a current vendor of the City, who provides landscape and maintenance services to various Departments. An ethics opinion was provided by the City's Ethics Officer, which determined that transaction does not present a prohibited conflict. A copy of email communication between Housing and Community Development staff and the Ethics Officer is available for this agenda item.

In accordance with Section 2-31 of the City's Code of Ordinances, the City Commission must make a determination that the property is not needed for City purpose and must declare the property as surplus and select a method of disposition. The method of disposition may be formal negotiations with an interested party, in this case, Marto Rentals 2, LLC.



Resolution No. 145-21 finding that City-owned property located at 1100 Okeechobee Road is not needed for City purposes, declares the property as surplus, and authorizes the negotiation of the sale with Marto Rentals 2, LLC.

**Background:**

The City engaged Raftelis Financial Consultants, Inc. to conduct a Water and Wastewater Rate Study and a Miscellaneous Fee Study. The single most important objective of a rate study is to determine if the existing monthly retail rates for service meet the projected expenditure requirements of the Utility to ensure and maintain sound financial operations and fund anticipated capital needs of the utility system. The Miscellaneous Fee study is a detailed review of each service provided to customers of the Utility in order to determine the actual cost to the Utility of providing the service.

Based on the findings of the Water and Wastewater Rate Study dated August 5, 2021, it is recommended the City:

1. Suspend the automatic rate increases scheduled to become effective October 1, 2021. The current Ordinance No. 4890-20 for Water and Wastewater rates, fees and charges were approved by City Commission on February 24, 2020. The Ordinance has a provision that on each October 1st all rates and fees, except system capacity charges, late payment fees, deposits and returned item fees, will automatically be increased by two and one-half percent (2.5%) for water, and four percent (4%) for wastewater. Public Utilities staff and its rate consultant, Raftelis Financial Consultants, Inc., have determined that a delay in implementing rate increases on October 1, 2021 will not affect the Utilities' ability to maintain its required Debt Service Coverage for FY2021/2022.
2. Revise Section 24 of the Rate Ordinance to reduce the automatic increases from two and one-half percent (2.5%) to one percent (1%) for water rates and maintain the four percent (4%) adjustment for wastewater rates, effective October 1, 2022.
3. Reduce the water and wastewater service charge for multi-family residential dwelling units to 80% of the existing single-family dwelling unit charge.

Reduce the amount billed in each commodity tier by 20% to reflect the lower level of service demand (80%); reduce the wastewater cap from 16 to 14 units. Wastewater above the cap is not billed to the residential customer. The commodity charge is per unit. A unit is one hundred (100) cubic feet (CCF) or 748 gallons. The commodity charge for each tier will not change and will remain the same as the single family dwelling unit.

The adjustment to the multi-family residential dwelling unit service charges, commodity tiers, and wastewater cap is estimated to reduce the average monthly bill for a multi-family residential dwelling unit by \$7.59 and reduce the annual water and wastewater revenues by approximately \$3.2M.

The Miscellaneous Fee Study dated August 5, 2021 proposes revising the existing rates for each of the fees as specified on Table 3 of the study. Based on frequency of services performed in fiscal year 2019, three (3) services represent roughly 74% of the services performed.

It is estimated there will be an overall decrease in revenue of approximately \$50,000 based on the proposed changes to the miscellaneous fees.

**Fiscal Note:**

The adjustment to the multi-family residential dwelling unit service charges, commodity tiers, and wastewater cap is estimated to reduce the annual water and wastewater revenues by approximately \$3.2M. It is estimated there will be an overall decrease in revenue of approximately \$50,000 based on the proposed changes to the miscellaneous fees.

The automatic water and wastewater rate increases were not included in the preparation of the fiscal year 2022 Water and Wastewater Operating Budget. The rates, fees and charges proposed in Ordinance No. 4965-21 are anticipated to provide for the recovery of the total revenue requirements of the City's Water and Wastewater Utility.

16. **Public Hearing and First Reading of Ordinance No. 4966-21 APPROVED amending the floodplain management standards for manufactured homes and providing for elevation standards which FEMA announced as prerequisites for communities to maintain a Community Rating System Class 8 or better for flood insurance rate discount purposes. The City of West Palm Beach is currently a Community Rating System Class 5 community, which is better than a Class 8 and secures up to 25% discount on flood insurance rates for West Palm Beach property owners.**

**Background:**

The National Flood Insurance Program (NFIP) is a Federal Emergency Management Agency (FEMA) program, which makes flood insurance available for owners of property located in a Special Flood Hazard Area, sometimes referred to as a Flood Zone. The program includes a rating system called the Community Rating System (CRS) under which the effectiveness of a community's floodplain management standards, and the community's enforcement of those standards, are assessed. The Community Rating System is administered by Insurance Services Office (ISO) on behalf of FEMA.

The Community Rating System ranks communities from a Class 10 up to a Class 1, with Class 1 being the highest class and securing up to 45% discount on flood insurance rates for property owners.

FEMA has announced floodplain management standards for manufactured homes and set elevation standards as prerequisites for communities to maintain a Community Rating System Class 8 or better for flood insurance rate discount purposes.

The City of West Palm Beach is currently classified as a Community Rating System Class 5 community, which is better than a Class 8, so the prerequisite announced by FEMA is applicable to the City. The proposed amendments to the City of West Palm Beach floodplain management standards will meet the prerequisite and allow the City to maintain its classification as a Community Rating System Class 5 community. That will enable West Palm Beach property owners to continue to benefit from flood insurance rate discounts of 25% for properties that are in a special flood hazard area and 10% for properties that are not in a special flood hazard area.
