2. Resolution No. 21-49 approving development incentives not-to-exceed \$900,000 for jobs created in the Downtown / City Center District.

Background:

Project Silver is an economic development project that is aimed at expanding a financial services company from the Northeast of the United States region to West Palm Beach. The City of West Palm Beach is currently being considered along with other cities in the region. Project Silver aims to bring approximately 300 new jobs, with an average salary of at least \$120,000. In return, the CRA proposes a relocation and job creation incentive modeled after the State of Florida's qualified targeted industry grant program. The CRA has offered

\$3,000 per net new job created in the City of West Palm Beach not-to-exceed \$900,000. Payment of the grant will be on a reimbursement basis upon submittal of required reports evidencing position created during the prior calendar year. Incentive payments will be made over a period of four (4) years. Each annual payment shall not exceed \$225,000, excepting the final payment. The final payment shall include all new positions generated in the prior calendar year plus any un-reimbursed position carried forward, provided that the total incentive payment shall not exceed the grant amount. Lastly, the company will receive expedited permit review through the City's Construction Services division for build-out of the new office space. The incentive agreement is based on a term sheet that was approved by the CRA Board on July 12, 2021. This project is also a result of the CRA's partnership with the Business Development Board (BDB) of Palm Beach County. Project Silver was introduced to the City and CRA through the BDB's office.

Fiscal Note:

Funding for the project will be dedicated in fiscal year 2023 at \$225,000 per fiscal year, not-to-exceed \$900,000.

Background:

Project Lake is an economic development project that is aimed at relocating a financial services company from the mid-west region of the United States to West Palm Beach. The City of West Palm Beach has been selected as the location for the company. Project Lake aims to bring approximately twenty (20) new jobs, with an average salary of at least \$460,000. In return, the CRA approved a term sheet through Resolution No. 21-13 on March 8th for job creation incentives modeled after the State of Florida's qualified targeted industry grant program. The CRA has offered \$3,000 per net new job created in the City of West Palm Beach not-to-exceed \$60,000. Payment of the grant will be on a reimbursement basis upon submittal of required reports evidencing position created during

the prior calendar year. Incentive payments will be made over a period of three (3) years. Lastly, the company will receive expedited permit review through the City's Construction Services division for build-out of the new office space. This project is also a result of the CRA's partnership with the Business Development Board of Palm Beach County. Project Lake was introduced to the City and CRA through the BDB's office.

The grant will not be budgeted until Fiscal Year 2023.

4. Resolution No. 21-51 approving a project funding interlocal agreement with the City of West Palm Beach for the funding of a City building improvement grant for Project Safari to improve office space and create jobs, in an amount not-to-exceed \$100,000.

Background:

The West Palm Beach Community Redevelopment Agency (CRA) works with the City's Economic Development Director from time to time to attract firms to the City and CRA areas. The WPB CRA has set aside specific dollars that can be used to help with brick and mortar projects that assist in the redevelopment of the Downtown / City Center, while also achieving City Economic Development goals.

Project Safari is a financial services firm in a targeted industry that will add to the Flagler Financial District cluster. The firm has started renovation of 5,738 sq. ft. of space in the City's central business district, committed to create five (5) jobs and will invest approximately \$1,000,0000 into their new space. In return, the City, through the funding provided by the CRA, will fund 10% of the building improvements up to \$100,000.

Employees of Project Safari have begun to move to the greater West Palm Beach area with the anticipate completion date of the building improvements to be completed by Summer 2022. The grant will be funded on a reimbursement basis. Project Safari will need to provide proof of capital expenditures for the project improvement; all required building permits have been pulled, paid, and closed; that a final certificate of completion or occupancy has been issued; and that the five (5) employees are operating out of the downtown office location. Once the documentation for the reimbursement has been reviewed and approved, the Economic Development Director will perform a site visit to the office location for final inspection of the project. Upon final approval by the Economic Development Director, funds will be disbursed. Project Safari will be required to remain in the City and keep the jobs in place for period of five (5) years. If the company fails to maintain the jobs or relocates within the five (5) year time frame, the grant will be required to be paid back. The project is consistent with the CRA's Strategic Finance Plan and the City's Economic Development Plan.

Project Safari is in Commission District 3: Commissioner Christy Fox.

Fiscal Note:

The funding will be disbursed one time as a lump sum grant for the project. This will be a one-time payment.
