**2. CIVILITY AND DECORUM**

The City of West Palm Beach is committed to civility and decorum by its officials, employees and members of the public who attend this meeting. The City Code, Secs. 2-31(8), 2-31(18) and 2-31(22), provides in pertinent part:

- Officials shall be recognized by the Chair and shall not interrupt a speaker.
- Public comment shall be addressed to the City Commission as a whole and not to any individual on the dais or in the audience.
- Displays of anger, rudeness, ridicule, impatience, lack of respect and personal attacks are strictly prohibited.
- Unauthorized remarks from the audience, stamping of feet, whistles, yells and similar demonstrations shall not be permitted.
- Offenders may be removed from the meeting.

### 3. RESOLUTION

- 3.1. Resolution No. 101-22 declaring the results of the March 8, 2022, General Election for City Commissioner for District 1.

**Staff Recommended Motion:**

**Background Information:**

A General Election for the purpose of electing a City Commissioner for the City of West Palm Beach was held on March 8, 2022, in accordance with the Charter and Ordinances of the City and the laws of the State of Florida governing and regulating the holding of General Elections.

Resolution No. 101-22 declares the results of the March 8, 2022, General Election as follows:

For City Commissioner District 1, the following votes were cast by the qualified electors residing and voting within said City:

For:	Martina Tate Walker	2,379	28.27%
For:	Cathleen Ward	6,037	71.73%

For City Commissioner District 3, Christy Fox was unopposed.

For City Commissioner District 5, Christina Lambert was unopposed.

- 4.1. Swearing in ceremony for newly elected City Commissioners for the City of West Palm Beach.

**Background Information:**

The swearing in ceremony for the newly elected City Commissioners is being held pursuant to Sec. 2-1, Code of Ordinances, which reads: "Sec. 2-1. - Commencement of terms of office. The term of office of a newly elected mayor or newly elected city commissioner shall commence at 5:00 p.m. on the fourth Thursday immediately following the regular election." The oath of office will be administered to the newly elected City Commissioners: Cathleen Ward (District 1), Christy Fox (District 3), and Christina Lambert (District 5).

**Background Information:**

The election of the President of the City Commission will take place pursuant to Sec. 2.05 of the City's Charter which reads: "Sec. 2.05. - Induction and meetings. After each annual city election, the newly elected members shall be inducted and assume office at a public meeting. At such meeting, the city commissioners shall elect one (1) of their number to the office of the president of the city commission who shall serve at the pleasure of the city commission."
