Background Information:

The primary objective of the proposed project is to replace the existing Howard Park Community Center with a modern and larger facility that will provide the City the opportunity to expand the number of activities and programs to fulfill resident's needs.

RFQ 19 20 412, Howard Park Community Center was a (2) Phase effort. The 1st Phase was to select the top two firms to provide conceptual designs for Howard Park. The evaluation committee selected Alfonso Hernandez and CPZ Architects. Phase II required the two firms selected to submit a conceptual design taking into consideration the public and City's needs as a result public engagement efforts and an outreach event held at Howard Park on August 24, 2021.

Alfonso Hernandez conceptual design total estimated cost \$4,982,048.92.

CPZ Architects conceptual design total estimated cost \$4,999,761.

The architectural firms will provide a final presentation of their final design and construction of the Howard Park Community Center followed by evaluation and selection by the City Commission sitting as the Selection Committee.

The Selection Committee will select one of the architectural firms with whom to contract for Phase 2 based on community preferences, the City's needs for the building, and the budget consideration using the following criteria:

- 1) Design preferred by community
- 2) Design addresses City needs
- 3) General estimated construction costs
- 4) MWBE commitment
- 5) Small Business participation
