1. Review facade articulation and non-active use screening for Formal Site Plan Review Case No. 22-19:

At the April 12, 2023, DAC meeting, Formal Site Plan Review Case No. 22-19 Soleste (410 North Rosemary) received DAC Special Review approval, however there was an additional condition levied by DAC:

As required by the City's ArtLife WPB Ordinance, the applicant has identified the location of the public
art within the proposed development. A placeholder of the public art, which will be located on the west
and east facades of the bridge connecting the two buildings, is shown on the Site Plan and Elevations
plans. Once the artwork is finalized, the applicant will present it to DAC before seeking City Commission
approval to ensure non-active uses are screened adequately, and that the facade articulation is suitable
with the artwork.

The applicant would like to present the artwork and revised elevations to the DAC.
