The applicant is requesting a 90-day TCO extension for permit 21080870 (Bldg. B) to ensure all equipment is in place for final inspections prior to requesting the CO. The applicant states the owner has had issues with the laundry equipment vendor and is currently negotiating a new vendor to provide dryers for Building B.

These cases were granted extensions by the board at the April 20 and August 17. 2023 meetings. At the August meeting the applicant stated they were waiting for completion of the landscaping, which was scheduled for the
