# **Background Information:**

Alisha R. Winn, Ph.D. is an applied cultural anthropologist whose work focuses on race, class, identity, educational disparities, historic preservation in communities, heritage education for youth, historic African American insurance companies, and oral histories. She received her Ph.D. from the University of South Florida in Applied Anthropology, MA in Anthropology (Georgia State University), BA in Anthropology (Florida Atlantic University), and a BA in Sociology (Bethune-Cookman University).

Dr. Winn currently consults in preservation and community building efforts for the City of West Palm Beach's Community Redevelopment Agency (CRA) in the Historic Northwest District and is project director for the Palm Beach County African American Oral History Pilot Project, enabling youth to preserve and document the lives of community elders. She provides professional development to teachers and students about cultural anthropology in the Palm Beach County School System and Cultural Programs.

Dr. Winn has consulted and served as lead facilitator for several community-engaged projects: Habitat for Humanity's Historical Plaque Project; the Historic Northwest Pioneer Banners; the West Palm Beach Museum Planning Project for the historic Roosevelt High School; the Storm of '28 Memorial Park Coalition, Inc., bringing educational awareness about the mass gravesite of the 674 Black victims of the 1928 storm; the African American Research Library Palm Beach County, Inc. (AARLCC); the Lincoln Park-Coleman Park Culture and History Committee; the Palm Beach County African Diaspora Historical and

Cultural Society, Inc.; and the Palm Beach County's School System's African and African American Summer Institute.

Per her agreement with the CRA, Dr. Winn presents her work to the CRA Board annually.

## **Background Information:**

# **Background Information:**

Last April 3, 2023, the CRA Board approved Resolution No. 23-9 for an agreement between the City, the CRA, and 300 Banyan LLC related to the construction of improvements to the 300 block alley located between Clematis Street, Banyan Boulevard, Olive Avenue, and Dixie Highway for a total amount of \$2,500,000.

The approved agreement includes the construction of the Phase I alley improvement on the portion of the alley immediately adjacent to the 300 Banyan office project being developed by 300 Banyan LLC (eastern portion of alley). The construction of the improvements in Phase I is currently underway.

As the construction advanced, it has been determined that some work originally contemplated for Phase II will need to be completed during Phase I. The additional work includes the conversion of overhead to underground utilities for Comcast and AT&T from the western boundary of the 300 Banyan project to Dixie Highway, and the preparation for Phase II of the underground connection of the FPL lines to be performed by the City next year. The cost of the additional work is estimated at \$450,000. Resolution No. 23-35 amends the original agreement to provide for the additional funding.

CRA budget for FY 22/23 included a total allocation of \$5,000,000 for the completion of the entire project. Resolution No. 23-9 approved the agreement for the funding of Phase I with a total cost of \$2,500,000 and funds have been encumbered. The remainder \$2,500,000 were allocated for Phase II. The proposed Resolution No. 23-35 will transfer \$450,000 from Phase II funding to Phase I.

Resolution No. 295-23, included on the November 13, 2023 City Commission agenda, is a companion item to this resolution and provides the City's approval for the proposed amendment.

Resolution No. 23-40(F) appropriates the project funding for Phases I and II in FY 23/24.

### **Background Information:**

The POTP Development Incentive Agreement for the Broward project (now known as Park West) was previously extended to a completion date of December 31, 2023. We had anticipated a certificate of occupancy date of November 30, 2023, which would have fit within the completion date.

While the building is 95% complete, due to circumstances beyond the control of the Developer, the project will not be completed by December 31, 2023. These include continued material delays, changes required to sewer laterals from the building, and additional infrastructure added by the City. Below is a list of the detailed items causing delays.

- Back ordered components for the electrical system. These are necessary to power up the building. Until the building is powered up, permanent power cannot be brought to the units.
- The north and east sanitary sewer lines did not comply as designed with the actual site conditions and had to be redesigned, reapproved, and now must be rebuilt.
- The City required the following infrastructure improvements:
  - a new water main has to be installed and the old one demolished;
  - storm drainage and piping have to be changed on Picadilly; and
  - a new sewer manhole has been installed at Picadilly and Broward.

The City improvements are at various stages of approval and will need to be completed by the City's contractor once approved. Roadways will then require restoration, curbing, and striping.

The Developer has requested an addition ninety (90) days to complete the necessary work for a certificate of occupancy and to finish the remaining 5% of the building. The requested deadline proposed by the Developer is March 31, 2024.

The extension to POTP's incentive agreement was presented to the CRA-Advisory Board on Friday, October 27th. The CRA-Advisory Board recommended unanimously in favor of the extension to March 31, 2024.
