## 1. <u>Cancellation of TDR Certificate No. 22-09</u>

On July 22, 2022, DAC approved the transfer of 37,894 sq.ft. of Transferable Development Rights from sending site of 627 5th Street to receiving sites of 464 Fern Street, 418 Fern Street, and the West portion of 401 S. Dixie Highway. On November 17, 2023, WPB Fern Holdings LLC submitted affidavit of cancellation of TDR Certificate 22-09.
