# WEST PALM BEACH APPROVES ANOTHER DISPARITY STUDY MARKS CONTINUANCE OF MINORITY/WOMEN BUSINESS PROGRAM

On April 15, 2024, the City Commission heard from several minority- and women-business owners, who shared their positive experiences with the Office of Minority/Women Business Programs. From the support offered by office staff to events held to make networking easier, the stories of assistance came from various business owners who have benefited from the Office's outreach.

After hearing a presentation from Director Frank Hayden, detailing the results of his Office's five years of work, the Commissioners commended the staff's contributions and approved conducting another disparity study. The Office plans to hire a consultant for the study by July – August 2024.

#### Re-evaluating how business is conducted in WPB

The upcoming disparity study will update the results of a 2016 disparity study, which examined the equitability of all qualified businesses to do business with the City and eventually led to the establishment of the Office of Minority/Women Business Programs.

The advantages of M/WBE Program are stated as providing:

- opportunities for M/WBEs to work with Prime Contractors and large firms as subcontractors
- free marketing of their company to other city vendors and at networking events
- contract bids or "sheltered markets" for M/WBEs ONLY

At the April 15 Commission meeting, local business owners attested to the tangible results of the M/WBE program since its inception.

"The continuation of this Office is an important part of the growing economic landscape of the City," said Michelle Brown, president of MBE-certified Kaliah Communications, Inc. "I am a direct beneficiary of the work the Office does to keep minority- and women business owners part of the City's ongoing development."
