**Background Information:**

In compliance with Section 380.093, Florida Statute (F.S.), the City of West Palm Beach has undertaken a Critical Facilities and Assets Vulnerability Assessment. This assessment, funded by a grant from the Florida Department of Environmental Protection through the Resilient Florida program, aims to evaluate the resilience of our City's critical facilities and assets, both public and private, against current and future flood risks.

The assessment, initiated in 2021, has identified and analyzed critical facilities essential for community functionality under varying flood conditions including sea level rise, storm surge, rain induced flooding, and the compounding of each.

This presentation will give a high-level overview of the modeling and findings of the assessment.

RESOLUTION NO. 167-24: A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF WEST PALM BEACH, FLORIDA, APPROVING THE INTERLOCAL AGREEMENT AMONG THE CITY OF WEST PALM BEACH, PALM BEACH COUNTY, THE CITY OF DELRAY BEACH, THE CITY OF PALM BEACH GARDENS, AND THE CITY OF SOUTH BAY REGARDING THE PALM BEACH WORKFORCE DEVELOPMENT CONSORTIUM; PROVIDING FOR AN EFFECTIVE DATE; AND OTHER PURPOSES.

**Background Information:**

Public Law 113-128 enacted by the Congress of the United States effective July 1, 2015, which Act is known as the Workforce Innovation and Opportunity Act ("WIOA"), established a program to provide universal access to workforce development services for the businesses and citizens of Palm Beach County.

The State of Florida's Workforce Development Board CareerSource Florida, Inc. created by the Legislature in 2000, has been designated by the Governor to take the lead in designing and directing Florida's workforce development strategy and to designate Local Workforce Development Areas. Palm Beach County, Florida has been designated by the Governor of the State of Florida as Local Workforce Development Area 21 ("LWDA 21"), and the Palm Beach County Board of County Commissioners is designated as the Local Chief Elected Official, the fiscal agent, grant recipient and administrative entity to administer Workforce Programs and such other funding sources as may be available to support workforce development activities for LWDA 21.

By Resolution No. 175-21, the City Commission of the City of West Palm Beach previously affirmed joining with Palm Beach County, the City of Delray Beach, the City of Palm Beach Gardens, and the City of South Bay to form the Palm Beach County Workforce Development Consortium for the purpose of establishing an Independent Special District and to implement Federal and State workforce development programs and related activities in Palm Beach County under the provisions of the

Workforce Innovation and Opportunity Act, the Temporary Assistance to Needy Families Act, the Wagner-Peyser Act, and the Florida Workforce Innovation Act of 2000 (“Workforce Programs”).

The Consortium members seek to re-affirm their participation in the Consortium and to execute an updated Interlocal Agreement to operate the Consortium in a coordinated and cooperative manner.

Resolution No. 167-24 reaffirms the City's participation in the Consortium and authorizes execution of the Interlocal Agreement.

**Background Information:**

The Quality Improvement System (QIS) incentive program is a Prime Time of Palm Beach County strategy designed to further increase after school program quality for their participants' activities/programs. The QIS is a performance-based recognition program that awards financial incentives to out-of-school time programs that go above and beyond in their QIS work. The award amount is based upon a tiered process through which a program demonstrates the implementation of advanced youth development and program management practices. These practices are in concert and direct relationship with a program's voluntary participation and work in Prime Time's QIS incentive program. Funding is provided by the Children's Services Council of Palm Beach County and is based upon the availability of funds and performance.

This past year, four (4) of the City's after-school programs were eligible to

receive a QIS Core Practices Development Grant through Prime Time's QIS incentive program. They have each completed the QIS core quality practices that aim to increase and maintain positive youth development, which leads young people to develop skills necessary to be successful socially, emotionally, and academically. Prime Time requires that the grant be spent on professional development, program supplies, field trips, special youth and/or family events, and other program expenditures.

Gaines Park Community Center, South Olive Community Center, Pleasant City Community Center, and Vedado Park Community Center have each been recognized for going above and beyond in their QIS work. Pleasant City K - 5th grade was awarded \$1,500; Gaines Park 6th - 8th grade was awarded \$1,500; Vedado Park 6th - 8th grade was awarded \$1,250; and South Olive K - 5th grade was awarded \$1,250.

**Background Information:**

Pursuant to the Florida Contraband Forfeiture Act, any local law enforcement agency that acquires at least \$15,000 within a fiscal year

must expend or donate no less than 25 percent (25%) of such proceeds. These funds may be expended upon request by the Chief of Police to the City Commission, and upon appropriation to the Police Departments' miscellaneous trust fund. Such funds may be used only for school resource officers, crime prevention, safe neighborhood, drug abuse education, or drug prevention programs, or such other law enforcement purposes as the governing body of the municipality deems appropriate.

Asset forfeiture is a powerful tool that provides valuable resources to state and local law enforcement that may not have otherwise been available. Staff also looks at the permissible uses of similarly obtained federal funds in order to provide guidance for the Chief and Commission on such decisions. Equitably shared funds must be used in accordance with the statutes and guidelines that govern the federal equitable sharing program as set forth in the current edition of the Department of Justice's Guide to Equitable Sharing (Justice Guide).

The State Forfeiture funds requested complies with the permissible use reporting category identified as law enforcement operations and investigations, which include payments to informants, purchase of evidence, "buy" money, reward money, payment for crime tip organizations, or payment for a specific reward for information in a specific case.

The State Law Enforcement Trust Fund expenditure of \$25,000; which the Chief of Police certifies is in compliance with Section 932.7055(5)(a), Florida Statutes, will be used for investigative funds to further complex criminal investigations.

**Background Information:**

The West Palm Beach Police Department (WPBPD) continues to actively recruit and hire qualified candidates for police officer positions. The WPBPD has hired several non-certified individuals to attend the Palm Beach State College - Law Enforcement Academy.

The WPBPD has secured a donation of fifteen thousand dollars (\$15,000) from The Fund for West Palm Beach Police to reimburse the police academy tuition costs for three (3) newly hired police recruits.

Resolution No. 157-24 accepts the donation and authorizes use for the indicated purposes.

Resolution No. 158-24(F) will recognize the receipt of funds and provide appropriations for reimbursing police academy tuition costs for newly hired police recruits.

**Background Information:**

On June 28, 2021, the City Commission adopted Resolution No. 124-21 allowing the City to become an affiliate of Keep America Beautiful Inc. and partner with non-profit organizations with shared litter reduction and beautification goals.

The City became an affiliate of Keep America Beautiful Inc. on February 22, 2022 and established the Keep West Palm Beach Beautiful (KWPBB) initiative. The mission of KWPBB is to inspire and educate the public to take action to improve and beautify the City. KWPBB collaborates with residents, volunteers, and community partners to achieve these goals.

Since inception, the program has participated in 64 events, collected over 26,713 pounds of litter, and cleaned and improved over 293 acres of parks with the help of 1,606 volunteers, resulting in over 4,128 volunteer hours. In recognition of these achievements, the program received the President's Circle Recognition Award from Keep America Beautiful Inc. in 2023.

KWPBB desires to solicit funds and/or in-kind services from community partners in order to achieve its mission. Approval of Resolution No. 160-24 authorizes the program to engage in fundraising activities and allows for acceptance of in-kind services in support of this initiative.

**Staff Recommended Motion:**

Approve Resolution No. 161-24 and the associated Services and License Agreement.

**Background Information:**

The City desires to install digital wayfinding signs, initially within the downtown, which would provide helpful locator information to residents and visitors.

City staff engaged with IKE Smart City, LLC ("IKE"), which is a leading provider of digital wayfinding technology, on the potential for providing wayfinding services to the downtown.

IKE is engaged in the development, installation, operation, and maintenance of interactive wayfinding platforms, including "IKE Kiosks." The City and IKE desire to coordinate efforts to implement the deployment of IKE Kiosks within the City of West Palm Beach and on the rights-of-way adjacent thereto, all in accordance with the terms set forth in the agreement.

The IKE Kiosks will provide a number of benefits to the public, including: multimodal mapping to destinations; businesses and other points of interest; real-time arrival and departure information for public transit; bike share and car share services accessed from an interactive map; and emergency communication, including a pre-emptive protocol for real-time posting of emergency and/or public safety communication, such as storm warnings, amber alerts, evacuations (including routes), and road closures.

The agreement with IKE provides for revenue sharing of the advertising proceeds from the IKE Kiosks with the City and allows for the inclusion of public service announcements. The agreement provides an initial five (5) year term, with two (2) "automatic" renewal terms, dependent upon the performance of the terms and conditions set forth in the agreement.

**Fiscal Note:**

Minimum revenue to the city is \$391,139.50 per year if there are at least 20 kiosks. If there are less than 20 kiosks, the number will be adjusted downward proportionally.

**Background Information:**

The City of West Palm Beach has been requested to donate property to be used for higher educational purposes. The property sought was acquired by the City by County Deed. Several of the parcels were deeded in exchange for the property deeded to the County for the Ball Park of the Palm Beaches, and the remaining parcel was deeded pursuant to a reversionary interest retained by the City. The property has not been used for City purposes since it was acquired. The requestor is proposing to use the property for higher educational purposes and intends to construct a campus. The project is contingent on the acquisition of several parcels within the City, which includes additional property currently owned by a third party.

The purpose of this agreement is to provide the requestor with assurances that should it be successful in acquiring the property and

approvals needed to create, fund, develop, and operate the campus, the City will convey its property to be used for higher educational purposes, which includes creating a higher education campus. The property will be subject to a reversionary clause should the property not be developed and a use restriction requiring the property be used for higher educational purposes.

Approval of Resolution No. 159-24 authorizes the method of disposition of the City-owned property, and Ordinance No. 5104-24 authorizes the Mayor to execute the conveyance agreement and any other documents deemed necessary to effectuate the purposes of the agreement.

**Background Information:**

The Code of Ordinances at Chapter 94, Article XIII places limitations on signage within the City including prohibitions on digital signage. Exclusions on such limitations are noted under Sections 94-402.a "unregulated signs".

The City desires to include digital kiosks that provide information on City events, public transportation, sites of interest, and other public interest information as an exclusion to the signage requirements. These kiosks will provide residents and visitors with valuable real time information,

while also generating revenue for the City.
