**Background:**

The swearing in ceremony for the newly elected City Commissioners is being held pursuant to Sec. 2-1, Code of Ordinances, which reads: "Sec. 2-1. - Commencement of terms of office. The term of office of a newly elected Mayor or newly elected City Commissioner shall commence at 5:00 p.m. on the fourth Thursday immediately following the regular election." The oath of office will be administered to the newly elected City Commissioners: Kelly Shoaf (District 1), Christy Fox (District 3), and Christina Lambert (District 5).

**Background:**

The election of the President of the City Commission will take place pursuant to Sec. 2.05 of the City's Charter which reads: "Sec. 2.05. - Induction and meetings. After each annual city election, the newly elected members shall be inducted and assume office at a public meeting. At such meeting, the City Commissioners shall elect one (1) of their number to the office of the President of the City Commission who shall serve at the pleasure of the City Commission."
